Subject: Statement of RoHS Compliance

ALMECO S.p.A declares that:

- the items supplied meet the requirements of Directive 2011/65/EU (June 8th 2011) concerning the "Implementation of Directive 2011/65/EU on the restriction of the use of certain hazardous substances in electrical and electronic equipment" including the Annex I;
- the supplied products satisfy the Legislative Decree May 12th 2020, n. 42 "Implementation of Directive (EU) 2017/2102 of the European Parliament and of the Council of November 15th 2017, amending Directive 2011/65 / EU on the restriction of the use of certain hazardous substances in electrical and electronic equipment" which amends, starting from June 6th 2020, the Legislative Decree March 4th 2014 n. 27 (RoHS II);
- the "Legislative Decree 4 March 2014 n.27 - Implementation of Directive 2011/65/EU on the restriction of the use of certain dangerous substances in electrical and electronic equipment" has been updated (GU General Series n.62 of 15/03/2014), consolidated text 2024 with the amendments/repeals from 2014 to 2024, based on the changes established by the "Decree of 17 October 2024 (Amendment of Annex III to the RoHS II Decree) – Implementation of delegated directive (EU) 2024/1416 of the Commission, of 13 March 2024, by amendment of Annex III of the Legislative Decree of 4 March 2014, n.27, on restriction of certain dangerous substances in electrical and electronic equipment (RoHS II)" (GU n.295 del 12/17/2024). Application starting from 1 January 2025;
- the products supplied do not contain the substances listed in ANNEX II of Directive 2015/863/EC (RoHS III) in a concentration higher than the maximum values allowed in all their parts and components, in particular:
 - Lead < 1000 ppm
 - Mercury < 1000 ppm
 - Cadmium < 1000 ppm
 - Hexavalent chromium < 1000 ppm
 - Polybrominated biphenyls (PBB) < 1000 ppm
 - Polybrominated diphenyl ethers (PBDE) < 1000 ppm
 - Bis (2-ethylhexyl) phthalate (DEHP) < 1000 ppm | New RoHS III



- benzylbutyl (BBP) < 1000 ppm | New RoHS III
 - Dibutylphthalate (DBP) < 1000 ppm | New RoHS III
 - Diisobutyl (DIBP) < 1000 ppm | New RoHS III
- all the components supplied by Almecco S.p.A respect the principle of induced conformity, to guarantee the maintenance of RoHS compliance of the finished product, in which they must be incorporated.
